GRADUATE STUDENT REMISSION:

Requires an appointment greater than or equal to 25% time but not more than 50%

For AY 2017-2018, the Academic Student Employee (ASE) fee remission amount is equal to 100% of the Student Services fee, 100% of the Tuition, and 100% of the GSHIP (health insurance) fee.

* Graduate Student Readers and Tutors who are appointed for less than 110 hours, but who subsequently complete 110 hours or more of actual work during the academic quarter, will be reimbursed for the mandated GSHIP fee and the Student Services Fee & Tuition fee remissions, unless paid by other university sources.

1. Campus-based fees include the Associated Graduate Student Fee, Student Center Fee, Bren Events Center Fee & Recreation Center (ARC) Fee.

Campus-based fees is not included in fee remission and generally, ASEs are responsible for paying these fees.

Eligible Non-Resident Ph.D. students who have Advanced to Candidacy are exempt from paying the Non-Resident Supplemental Tuition for a maximum of three calendar years; assessment is equivalent to that of a Graduate Student Resident.
