*Academic Student Employees (ASEs) who are appointed for less than 110 hours, but who subsequently complete 110 hours or more of actual work during the academic quarter, will qualify for the mandated GSHIP Fee, the Student Services Fee, Tuition, and Campus-based Fee Remission Program, unless paid by other University sources.

- Effective Fall 2018, new undergraduate, professional, and graduate students are assessed the **One-time Document Fee** of \$80. Eligible students are able to use financial aid to cover the Document Fee. The Document Fee only applies to new students and is covered by remissions.
- Total Assessment for Non-Residents includes **Non-Resident Supplemental Tuition (NRST)**, which is NOT covered by ASE Fee Remission. Eligible Non-Resident Ph.D. students who have Advanced to Candidacy are exempt from paying the Non-Resident Supplemental Tuition for a maximum of three calendar years; assessment is equivalent to that of a Graduate Student Resident. - The **UC Graduate and Professional Council (UCGPC) Fee** is a non-mandatory fee that graduate students are assessed during the fall (\$3), winter (\$2), and spring (\$2) terms to support the systemwide UC Student Association. Students may elect to opt-out and once the opt-out is elected students will not be charged the fee unless they change their election for a later term. Effective 24-25 academic year, remissions will NOT cover the UCGPC fee if students don't elect to opt-out.
